1. Terms and Conditions

Update to General Terms and Conditions for your award: The purpose of this amended Notice of Award is to inform the recipient that the General Terms and Conditions for [non-research](#) grants and cooperative agreements have been updated, effective January 23, 2024, to reflect current regulations and requirements for federal financial assistance.

A summary of the revisions to the General Terms and Conditions is outlined below.

New Term Applicable Now

Changes to Closeout Requirements

- In accordance with 2 CFR 200.344, recipients must submit all closeout reports identified in this section within 120 days of the period of performance end date (previously was 90 days).
- Final Federal Financial Report (FFR, SF-425) – the Final FFR, SF-425 is required and must be submitted no later than 120 days after the period of performance end date through recipient online accounts in the Payment Management System (previously was 90 days).
- If recipients do not submit all closeout reports identified in this section within one year of the period of performance end date, then CDC must report recipients' material failure to comply with the terms and conditions of the award with the OMB-designated integrity and performance system (currently Responsibility/Qualification (R/Q) section of [SAM.gov](#)).

Clarifications to Existing Terms
