Missouri Public Health System at a Glance



Health Profile for Butler, Dunklin, New Madrid, Pemiscot, Ripley, Stoddard, and Wayne Counties

Many health indicators in these counties are worse than those in the state of Missouri as a whole. For example, compared with the entire state of Missouri, the death rate due to stroke is 19% higher; death rates due to colorectal and lung cancers are 25% and 28% higher, respectively; the infant death rate is 21% higher. Alarmingly, the death rate due to motor vehicle accidents in the counties is more than two times and nearly three times the state and national rates, respectively. Also, the hospitalization rate of alcohol- and substance-related mental disorders is 64% higher than the state rate; the teen birth rate among girls aged 15-17 years is almost twice as high as the state and national rates.

The asthma hospitalization rate among children in the counties is more than twice the rate for Missouri as a whole. Specifically, of all counties in Missouri, Dunklin County has the highest 5-year (2001-2005) average rate of asthma hospitalizations among children under 15 years of age (111.1 per 10,000 for Dunklin County vs. 23 per 10,000 for the entire state).

Among the health risk behaviors, adults in the counties are 42% less likely to exercise and 33% more likely to be current smokers than all Missouri adults; the utilization of the pap test and signoidoscopy is lower in the counties. Furthermore, the rate of smoking during pregnancy in the counties is 62% higher than the state rate and almost three times as high as the national rate (see table below).

Selected Public Health Activities in Butler, Dunklin, New Madrid, Pemiscot, Ripley, Stoddard, and Wayne Counties

Cancer Screening

Missouri's <u>Show Me Healthy Women Program</u> (SMHW) provides free breast and cervical cancer screenings to women meeting age, income, and residency criteria throughout the state. Health care providers delivering the SMHW services within these counties can be located through a clickable county map at www.dhss.mo.gov/BreastCervCancer/ProviderList/ProviderListMap.html.

Health Disparities Collaborative

The National Health Disparities Collaborative (NHDC) is dedicated to eliminating health disparities for different minority populations, poor people, and women. The federally qualified health centers (FQHCs) enroll in the NHDC and implement disease management activities to reduce the secondary complications related to diabetes and cardiovascular disease. FQHCs participating in the diabetes health disparities collaborative located in the counties are through the Southeast Missouri Health Network (main site in New Madrid County and other sites in Dunklin and Stoddard Counties).

Dunklin County Asthma Initiative

Missouri Asthma Prevention and Control Program (MAPCP) does not provide direct funding to the communities for these asthma interventions. Existing community resources are utilized and enhanced through MAPCP and its partners by providing planning assistance; training of school nurses, primary care physicians and other health professionals; environmental assessments; and other technical assistance as needed. This initiative plans to institutionalize the asthma interventions at a grass-roots level to increase the probability of sustaining the project over time.

Tobacco Smoking

The <u>Missouri Tobacco Quitline</u> offers telephone counseling and resource materials to help Missourians stop tobacco use. The Quitline number is 1-800-QUIT-NOW (1-800-784-8669).

Missouri Model for Brief Smoking Cessation Intervention trains health care professionals throughout the state in the 5A's technique as a means to reduce smoking among pregnant and women of child-bearing age.

The Tobacco Control Program of the Missouri Department of Health and Social Services promotes and assists employers, owners of public places, schools and hospitals to adopt policies of smokefree workplace, public place, and campus. The program also provides support for building youth advocacy groups to discourage smoking and to advocate tobacco control policies.

Fetal Alcohol Syndrome (FAS)

The Missouri Fetal Alcohol Syndrome Rural Awareness and Prevention Project (MOFASRAPP) aims to develop and implement an integrated systems framework for prevention of and surveillance for alcohol-exposed pregnancies and FAS. Women 18-44 years of age looking for help in cutting down or quitting drinking can call a toll-free number (1-800-645-6164) for the Self-Guided Change phone and mail intervention. These counties are within the areas covered by the project.

Home Visitation

The <u>Building Blocks of Missouri</u> program is a prenatal and early childhood nurse home visitation program that promotes healthy and safe parenting and home environment. The program services are available in Dunklin, New Madrid, and Stoddard Counties, and delivered through Southeast Missouri Hospital Home Health.

The <u>Missouri Community-Based Home Visiting</u> (MCBHV) Program utilizes nurses and paraprofessionals and provides intensive sustained visits and community services to address the needs of families who are most at risk of infant mortality or morbidity, and child abuse or neglect. New Madrid County is within the MCBHV services area.

Youth Health

<u>Missouri's Federal Abstinence Education Program</u> directly supports abstinence education throughout the state to delay sexual activity until marriage and to decrease out-of-wedlock pregnancy and frequency of sexually transmitted diseases among adolescents. The program reaches approximately 30,000 adolescents and their parents annually.
