II. Subcommittee Reports			
Pediatrics Subcommittee Patricia Casey, Chair	Trish Casey reported an EMSC meeting is being held today with some national speakers presenting. The meeting will run until about 2 pm today. Several Missouri peds representatives went to a national meeting recently. They found Missouri leading in some areas and not as advanced in others. They are bringing the info forward in their committee. National EMSC frustrated about trying to get data back to examine. Data collection and analysis continues to be challenging. Trish will do a detailed summary of the national meeting and of the EMSC meeting being held today. Liz Kendrick has and EMSC grant for equipment. Hi-Fidelity pediatric simulators are available for all in MO for training. See EMSC website for details. STARS model is available if anyone wants to explore it. B. Trauma Subcommittee Dr. David Gustafson, Chair	Dr. Gustafson reported the trauma committee is working through the regulations and will present their recommendations to physician organizations and others interested, including DHSS. Dr. Gustafson said the data collection company, Biospatial, did webinars at the July 30 SAC meeting and at the September meeting of Reg A/West Central. Biospatial has contracts with Florida, SC and AMR. They are funded by DHS and ASPR. Biospatial provides data at zero cost to states, etc. They are effective in doing trauma analysis in other states. MO DHSS would need to sign a letter of agreement with Biospatial to establish the collection of		

	data in Missouri. Dr. Gustafson presented a letter to SAC as Trauma Chair and Reg A Chair asking SAC to support an agreement with Biospatial and MO DHSS	Dr. Andrews to correspond with DHSS to relay the support of Biospatial and DHSS working together for effective data collection/analysis in MO.	
C. Legislative Subcommittee Mark Alexander	 Mark Alexander reported the subcommittee met this morning. Gov. Greitens (before he left office) had ordered all regulations be reviewed and condensed if possible. The legislative committee met twice a month for over a year and finished the project last fall (2018). Mark said the revised regulations may be starting to move through the system at DHSS. State can now receive NEMSIS3 uploads. TCD statute has been rewritten. It changes the design of the TCD system so it will be more flexible to keep up with changes in the standards of patient care. It has not been introduced in the legislative process yet. There is a movement to ask for \$40,000 for each region to support data collection etc. In order to have sustainability, it would be requested to be a line item in the state budget. 	Mark Alexander will continue to monitor legislative issues and bring relevant issues to his committee and to SAC.	
D. Education Subcommittee Chuck Doss, Chair	Chuck Doss reporting. The meeting last week was cancelled when the speaker had an emergency. The meeting has been rescheduled for Sept. 25 th at noon. Education standards and scope of practice will be discussed.		
E. Air Ambulance Subcommittee Ruby Mehrer, Chair	 Ruby Mehrer and Christy Dressler: Air ambulance met with the Regional Medical Directors July 30th and August 28th. Committees have been formed to update utilization guidelines and other documents. Today documents from a literature search were reviewed to determine what new information is coming out and to consider changes for our utilization and early activation documents. Work will continue in this 	Will continue to meet with Regional Medical Directors in order to have a synchronized effort in updating documents as well as legislative efforts.	

	 Anticipated discussion with the Reg. Medical Directors did not take place due to Dr. Braithwaite diverted to the scene of an accident for possible amputation. (Person extricated successfully without amputation but arrival in Jeff City delayed). Dr. Braithwaite and Jason White scheduling an appointment with Rep. Wiemann to explore his intentions for 2019 and also to discuss possible options. 	Dr. Braithwaite and Jason White to keep air ambulance and regional medical directors informed of legislative discussions.	
Dr. Andrews Remarks on Biospatial	Dr. Andrews briefly reviewed the Biospatial presentation at SAC July 30. She reiterated that the Biospatial product is free for state users. Homeland Security and ASPR pays Biospatial for reports from the scrubbed data. Dr. Andrews supports the data collection abilities of Biospatial and would like the opportunity to use it. At a state TCD meeting last week, Dr. Andrews and Dr. Braithwaite gave information on the product to Dean Linneman. He will spend some time reviewing Biospatial capabilities and then will make recommendations to the appropriate people at DHSS. Biospatial works through DHSS to collect data. An agreement would need to be signed by both entities.	Dr. Andrews and Dr. Braithwaite will report Dean Linneman's findings and recommendations.

	Community Paramedics discussion. Dr. Stilley, in response to advanced practice paramedic efforts, reported NAEMSP chapter is drafting something to create a high-level paramedic. Wants to bring the group forward with a bill all can support. Idea is similar to the community paramedic education with an emphasis on chronic and on-going conditions. Education requirements would be a bachelor's degree for advanced and critical care paramedics. The proposal includes reimbursement to be able to be paid as health care professional. Licensure would be under board of healing arts. The push should be physician driven. Critical Care Certification would be determined by education and certification. More emphasis critical care education.	Dr. Stilley will keep SAC and pertinent committees updated on his efforts.
