# STATE MEETING REPORT JOHN RUSSELL **DISCUSSION** Legislative Report: Many items at the legislative level have been delayed due to the recent election and appointment of new elected officials. The Missouri Ambulance Association continues to work in favor of Recognition of EMS Personnel Licensure Interstate Compact (REPLICA). There are currently 7 states who have passed legislation and 17 who are evaluating the legislation. If 10 states pass legislation an Interstate Commission will be formed. It would benefit Missouri to be a member of this commission. IGT continues to be evaluated. The movement continues to support moving from a supplier status to provider status. 19 CSR 30-40.375 – Discussed the requirements for electronic patient care reporting. Specifically, handoff vs. trip data collection. Work needs to be done at a local/regional level. Efforts are being made to promote patient safety through the importance of patient handoff. CONCLUSIONS The Missouri Association of Air Medical Services (MOAAMS) has sent a letter in support of REPLICA. COMMITTEE MEMBERS

- File of Life Debbie discussed the utilization of file of life. A sticker is placed on the front of the individual's door indicating they have a file of life. The patient's medical information is contained within the file located on a magnet on the refrigerator door.
- Road ID Debbie discussed the product which provides identification, emergency contact and medical information. The product comes in various options (bracelets, pendants, shoe tags, etc.). Many of the products allow for the option to utilize a website that includes a serial number and pin code to access the individual's medical history.
- STAR Program Debbie discussed the opportunities for increased utilization of the program. Currently, Perry County and Sainte Genevieve are utilizing the program. St. Louis Children's Hospital and Cardinal Glennon will provide any specific education needed to treat a child identified through the program for local providers.
- EMS Hometown Heroes Governor-Elect Eric Greitens is planning his inaugural event for January 9, 2017 with the theme of honoring heroes. His team has reached out to the EMS community to help identify EMS heroes to honor during the celebration. Please respond to Ruby Mehrer at ruby@lifeflighteagle.org to help identify candidates prior to December 9.
- Stroke Witness Cards April discussed the process for utilization of the Stroke Witness Cards. EMS should provide the cards to stroke witnesses on scene to call Saint Francis Medical Center with time critical information to help expedite treatment with thrombolytic therapy in appropriate candidates. Card were distributed to those in attendance. April is available to present to organizations if needed for further education. Extra Stroke Witness Cards will be stocked in the Emergency Department.
  - A concern was voiced that if a card was given to a family and the patient was transferred to a different facility would we be able to identify that on the call.
    - An addition will be made to the form completed by the transfer center to verify the facility the patient is being transported.
- Debbie will be transitioning into a new role at Southeast Health. She will be the new TCD Director.
- STEMI Survey Monkey Debbie is currently in the process of uploading images. Once completed the survey will be sent to organizations for distribution.
- The Missouri Association of Air Medical Services (MOAAMS) will be offering a pre-conference at the EMS Expo on the EMS role in active shooter situations. Further details will be provided at upcoming meetings.
- Does the region still have a process for Critical Incident Stress Debriefing?
  - Debbie will verify the process and report back at the next meeting.
