Dr. David Gustafson, Chair	cuts of the state TCD budget and its impact on trauma. American College of Surgeons has a lag time of 12-13 mo. to get a site visit scheduled then at least that much more time to have the review/visit. There may be as many as 26 hospitals affected in Missouri if the state does not do site reviews to determine trauma center levels. A letter will be drafted to the appropriate officials to explain the need for the state to allow a 5-year transition time before withdrawing from site reviews. Trauma said will write letter to budget to say needs to be Trauma and Triage regulation was discussed. The committee is not opposed to it but not sure the regulation will make a significant difference in current practice. No meeting in March. Next meeting April 24 th .		
C. Legislative Subcommittee Mark Alexander, Chair	Mark Alexander reported that the legislative subcommittee is working to advise DHSS as EMS regulations are being reviewed. There was a meeting Feb 13 at Boone County Fire Protection District in Columbia that was attended in person and on line. About 20 people participated. Licensing regulations for ground, air and EMRA were combined and ready to forward to the state. Believe it is ready for SAC to have its first reading. Next meeting at 1:00pm on March 13 th at Boone Co after EMS Day at the Capitol		

Medical Directors regulations were reviewed. Consolidation in process, not finished. Considering medical directors class on responsibilities of EMS Medical Directors. Board certification being discussed. Also, to be included is a contingency plan if a medical director quits. If there is no medical director, the EMS agency must call for orders. May not work off protocols. Up to 120 days is allowed to get medical director replaced.

Communicable disease regulation review includes working closely with MO Hosp Assoc. Will get consistent approach, so everyone protected when exposed.

A new regulation will address patient hand-off which is recognized as a high-risk time for error. Patient hand off was removed from .375. North Central Region has good form for a patient hand-off template.

Jason White reporting:

The first efforts to establish a statewide 9-1-1 system began 20 years ago. Efforts continue. Jason said letters in support of the bill this week would support the action anticipated on the floor. In the past certain Senators have not been supportive but the report that was mandated by SB503 that passed in 2017 is finished and has provided the Senators with data that is meaningful to them. Some Senators indicating more support is possible.

EMS Compact (Replica) Bill is moving. Fire Fighters concerns are being addressed.

General EMS bill—clean up language—moving LODD –hearing Wed Blood Draw—MO Hosp Association has a bill that is helpful with this issue.

Triage and transport regulation not discussed.

Communicable disease regulations are being combined into

	one regulation. Deemed consent is already included in language so treatment for exposed health care workers should not be delayed. EMS working closely with MHA to coordinate requirements etc. The regulations rewrite group will meet every 2 weeks until spring. Any interested person can attend and participate.

New Business	Mark Alexander gave an update about TCD. \$155,000 withheld from DHSS budget will reduce state site reviews for TCD centers. Letters from MHA, AHA and other disciplines
	needs to be sent to the Governor. There are great concerns on how this impacts TCD system. The goal is to continue to have good patient outcomes
	Bill Koebel DHSS said the reduction of about \$150,000 is in Sections for Licensing and Standards and affects all 3 staff—trauma, stroke, STEMI. Plans are just being developed. The reduction will not be shared by other departments.
	Helen Sandkuhl asked if this was a result of previous 50 and SB 501 language?
	Bill Koebel says governor's recommendation came after legislation enabled facilities to go to nationally recognized bodies to get TCD Level designations instead of having a state site visit/review.
	Trauma Committee's concern is the American College of Surgeons only evaluate resources and do not designate Levels I, II, III etc.
	Bill Koebel says SAC has a recommendation, then SAC get letter drafted and sent.
	General Assembly has to have budget back for Gov signature 1st week of May. Letters should be delivered no later than April 15.

Jason White said MAA's lobbyist and MO House budget committee needs to hear support of keeping those 3 positions justified. Support needs to be expressed.

Mark Alexander said the law remains for TCD system so doesn't make TCD system go away but does question how it would be able to function.

In answer to a question, Bill Koebel said he was not sure if Joint Commission assigned Chest Pain levels?

Jamie Blackwell met with Rep. Fitzpatrick—he said probably TCD money would probably be available for another year. Jamie said it takes 3 to 5 years to get ACS visit so some designations could lapse while waiting.

It was mentioned that \$38,000 for ACS first visit is prohibitive.

Helen Sandkuhl said there are national structures for Stroke and STEMI but not for trauma designations.

Dana Spruell indicated a need to have longer window to transition

Mark Alexander said to get these thoughts into words that can clearly communicate the impact to the Governor. SAC must do a letter but also Med Directors need to as well.

Dr Tan says SAC should advise Governor of importance of TCD system—great points can be made.

Trauma, Stroke and STEMI disciplines need to get important points together to put in letter to the Governor.

Trauma letter will be drafted by Jami Blackwell and Dr. Gustafson.

Stroke Bob Patterson will get his stroke people involved.

	STEMI Kristi Baden, Central Region—Boone Hosp. Mark says to organize regions and hospitals to write letters. We need to communicate the impact of the TCD system to the Governor. Dr. Tan says 2018 is 10 years of the TCD system Need many letters from public and patients. Lori Freeman suggested every two-week meeting if working on critical issues.
