Call to Order

Bob Patterson, Chair, called the Regular Meeting to order at 1300. Welcome and introductions were made.

Establish Quorum/ Review Agenda

Review and Approval of Previous Minutes

TCD Presentation

"Non-PCI Facility Challenges: EMS Response to TCD Patients" was presented by Dr. Frank Kim, Mercy Cardiology, and Dr. James Ceaser, CoxHealth Cardiology. Goals of this regional work group include:

- Review all cases for STEMI patients with DIDO > 30 minutes from referring hospital
- Develop a multi-system organizational process

Old Business:

TCD Update and Report from Subcommittee

- Trauma (Velvet Shoults) group will be selecting an issue to draft a guideline on; have initially chosen spine boards. Will draft the guideline and then distribute. Future guidelines may include TXA, Ketamine, GCS scores, airways.
- STEMI (Mary Ann Huff) STEMI quality project is Prehospital STEMI activations. Current results range from 0-89%. Also focusing on STEMI protocols in all facilities.
- Stroke (Eddie Spain) Handout distributed with information on stroke education, Sharepoint development, and Metrics. Metrics will include: 1) Onset of S/S (when patient last known well), and 2) obtaining contact number for family/relative.

Legislative/SAC Update – Mark Alexander

- A handout on community paramedics was distributed
- 911 initiative (Sonny Saxton) bill failed in 2013; greater grass roots effort in 2014 to get this passed. Any device needs to be a funding resource. Handout "911: Success in 2014" distributed. Bob will send out via email list, a template for contacting legislators, and supporting documentation.
- Mark indicated we are a couple of weeks into the legislative session. EMS legislative issues this year Medicaid expansion will likely dominate the scene in Jeff City; the 911 bill has been introduced; licensure action for EMS, making sure individuals being investigated have due process rights; minor revisions to the regional EMS committees; blood alcohol drawings.
- EMS Day at the Capitol is scheduled for 3/11/14 from 0830-1200. All are encouraged to attend. Booth spaces available; if interested, contact Jason White or Mark Alexander.

• Community Paramedic update: A handout was distributed denoting proposed clinical experience and classroom hours. Currently there are a number of initiatives being proposed around the state.

Dr. Janet Jordan reported that recommendations were given at an initial task force meeting. Bill defining community paramedics came first, but no funding or local education programs. Dr. Jordan referenced Hennepin County (Minnesota) program as a potential model. Terminology being used is "integrated mobile healthcare provider". The intention is to cover the patients who fall between the cracks; not the ones covered by home health.
